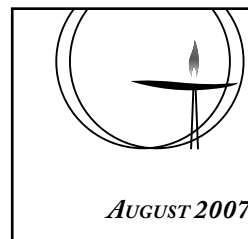

August 5th - *The Miracle of The Jefferson Bible* by Scottie McIntyre Johnson. One of the Unitarian forbearers we UUs claim is Thomas Jefferson, who created his own New Testament for himself by literally cutting out the passages about supernatural occurrences, leaving only the ethical teachings of Jesus. What does this act, the creation of Jefferson's Bible, say about our heritage as liberal religionists and how might it inform our own individual searches for religious truth and meaning?

August 12th - *What Are You Willing To Risk?* by The Rev. Mark Walz. An uninvited visitor to my door brought me a gift I could never have imagined: a chance to articulate my faith in a new and compelling way. And through this meeting I found myself re-called to the Ministry of our shared faith. The Rev. JPS Announcing

Policy Changes

On August 28th, the JPS Hospital Board will be announcing their position relaxing the stringent requirements for eligibility of health care for the working poor and indigent people of Tarrant County. As we know from newspaper articles, etc., Allied Communities of Tarrant (ACT) has been very active bringing about this reconsideration of requirements. Some of our membership has been instrumental in attending work groups and analyzing the data throughout the year.

The ACT organization has requested that support for the policy change should be made apparent by attendance at the meeting. To be effective, supporters should be present in the chamber in the Administration/Admissions Building by noon, August 28th. Such a gathering would also demonstrate some of our UU concepts - justice, equity and compassion - by using one of the elements of the democratic process.

2007 Statement of Conscience: Moral Values for a Pluralistic Society

(Originally published at UUA.org)

In June 2005, the General Assembly of the UUA selected "Moral Values for a Pluralistic Society"

as the issue suggested to congregations for two years of study, action, and reflection. On June 23rd the Assembly approved a final statement as official policy for the Association.

The statement reads, in part:

People often make religious claims about controversial issues such as reproductive rights, stem cell research, the death penalty, and the teaching of evolution. Their efforts to advocate one perspective, to the exclusion of others, are influencing every branch and level of government. Consequently, the United States is moving away from its constitutionally mandated separation of church and state.

It is time for Unitarian Universalists to assert and defend two basic principles underlying the American Constitution (1) the basic principle of freedom, that is the right of all human beings to follow a life of their choosing, as long as others are not harmed, and (2) the basic principle of inherent equal dignity of all human beings, which includes the right of all human beings to equal justice.

The Assembly also passed six Actions of Immediate Witness (AIW). These statements are calls to action presented by delegates and relate to pressing social concerns. The titles of the 2007 AIWs are:

Support for the UN Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW)

Support Immigrant Families—Stop the ICE (Immigration and Customs Enforcement) Raids

Support Comprehensive Sexuality Education Legislation

Stop US Sponsored Torture—A Religious Call to Action

Repeal "Don't Ask, Don't Tell"

Pass the Employment Non-Discrimination Act with Transgender Inclusion and Protection

Transgender rights were a focus of the annual convention, beginning with the President's report highlighting support congregations have offered transgender people who face discrimination in their local communities. The assembly offered a Responsive Resolution on Transgender Issues to recognize the need for anti-discrimination laws openly affirm support for transgender people.

The final texts of the 2007 Statement of Conscience, Actions of Immediate Witness, and Responsive Resolutions will be available on the UUA's website within the next few days. Please check UUA.org for complete details.

What Happening with RE?

This is your Director of Religious Education letting you know what exciting things are happening in our RE program. I am pleased to announce that as of July 1st the DRE position has been promoted from quarter-time to half-time! This vote to extend the position's time once again shows how this church makes religious education a priority. Thank you for supporting our children!

As we presented on RE Sunday, the children have completed our Peace curriculum. The children are now using the skills they learned to live peacefully at home and at school. They have shared with me many stories of how they have resolved arguments with their friends and helped promote peace in their community. Hearing these stories is proof that our teachers have done a fabulous job this past school year.

Now that we have studied peace, we will be studying about our UU identity. The children will focus on and answer such questions as “What do UUs believe?”, “What makes us UU?”, “How do UUs act?”, and “How is UU different from other religions?” To help answer the last question, four summer sessions will be devoted to learning about four diverse cultures. Report on the Kennedy Fund

The Gino Kennedy Fund group met on July 5th. Charles Palmer presented the results of his inquiries into KIVA and FINCA. The group voted to work with KIVA. As requested, Charles set up an account the next day. As a KIVA lender, the committee is known as Kennedy Group 4134. Loans of \$150.00 each have been made to four women: Maria Teresa Carrillo Hernandez and Nohemi Trinidad Mendez Borges in Mexico, Carmen Amparo Cancino in Guatemala, and Lucy Wanjiku Chege in Kenya.

Maria requested a KIVA loan to help enlarge her used clothing business; Nohemi to buy catalog shoes, which she sells in her community, as well as produce she grows – she wants to make a down payment on a truck to deliver her goods; Carmen hopes to increase her business by purchasing chickens and drinks to sell in her store; Lucy is involved in selling milk in her own and surrounding communities and needs to increase her milk stock and storage facility.

Service Project News

In July 2007, Westside adopted a new approach to funding our service projects. Each month, non-designated plate offerings are donated to a worthy recipient organization. During July, our recipient was West Aid. So far, the results reflect that this is a new approach that members are gradually becoming more accustomed to. Please be generous!

Suggestions for future recipients of service project plate offerings are encouraged. Please route them through Charles Palmer, WUU treasurer, at charles.palmer@tyson.com. Your Board of Directors will review the recipient's qualifications with two simple criteria: 1) "Do donations to the recipient further our church's vision and mission?" and 2) "Are the recipient's values in sympathy with the seven Unitarian Universalist principles?" Service project donation recipients may be repeated throughout the year based on need and number of participating recipients.

Report from Building Repair and Improvement Committee

On July 8th, the BRIC presented an initial draft of its building/grounds repair/improvement plan to the church board. Board approval of the BRIC's recommendations to hire a landscape architect and plans for space allocation were two key outcomes from the meeting. Additionally, the board approved the BRIC's proposal to coordinate three church work days prior to the November 4th open house and the BRIC's intentions to address some immediate projects relative to tree trimming and structural repairs.

In deciding whether to pursue professional guidance regarding improvements to the building's

exterior, BRIC member Maria Schmidt researched the difference between a landscape architect and a landscape designer. Both provide a master plan, but the scope of the landscape architect's is broader, addressing all aspects of the building's exterior, including: paint, gutters/downspouts, signage, lighting, grounds and code compliance. The landscape designer's plans are generally limited to the plants on the grounds and in the flowerbeds.

Maria met with two landscape architects and two landscape designers and, at the July 8th meeting, presented her findings to the board. During the meeting the board agreed that the master plan provided by a landscape architect would provide a "road map" for addressing both long and short term goals and improving the overall "curb appeal" of the building. The board asked the BRIC to obtain three proposals so that a landscape architect could be selected at the July 21st board meeting. Details about the landscape architect selected, along with ongoing communication regarding the plan they prepare will be shared with the congregation once a final decision is made.

The board's approval of the BRIC's recommendations for space allocation was also critical to the BRIC's plans. Jill Jung agreed to be the BRIC member responsible for researching this particular need, reviewing all requests for space submitted and meeting with various church members to ensure she had a clear understanding of the congregation's needs.

The board's approval of space allocation included use of the room closest to the building's main entrance as the minister's office and the designation of the room adjacent to it as a combination church/admin office. Jill also supported the proposal to convert the "art" room (located off of the fellowship hall), formerly occupied by Angel Montessori, into a combination nursery/storage area for use by the religious education committee. Additional plans were discussed for maintaining a library/quiet meeting area in the small space located near the front of the sanctuary, as well as plans for finishing out the room on the opposite side.

Jill will also work with other church members to prepare the space for use, whether that means purchasing furniture, selecting paint or planning for future enhancements. Jill also informed the board on July 8th that as the congregation grows, and its needs change, the aforementioned plans for space may need to be modified.

The BRIC also sought the board's approval to

schedule three church work days prior to the open house on November 4th. The BRIC selected three Saturdays: August 11th, September 29th and October 20th. The dates were chosen specifically because there are currently no other events taking place at the church at that time. Very specific details of what will be accomplished during these work days will be posted on the newly designated BRIC UPDATE bulletin board, located in the hallway near the sanctuary.

The BRIC wants to make it very clear that while it can use as much help as possible, it understands that Saturday mornings tend to be 'choc' full already! Those who decide to give up their time to participate on one or all of these work days can be confident in knowing each day will be organized and that every minute of time given will be put to good use.

Finally, BRIC members Bob Vann, John Huffman, and Gayle Elleven are all working to tackle several behind the scenes tasks to ensure our building is safe and sound, and that we are on track for our November 4th event. More details about what is being done and when other tasks are scheduled for completion will be posted on the BRIC UPDATE bulletin board.

Update from the Committee on Ministry

The Committee on Ministry (COM) is charged with the responsibility for oversight of the health and wellbeing of the ministry within the congregation. To that end, the committee meets monthly with Russell to discuss issues which have arisen. The committee will hear, in confidence, any concerns in this regard which are raised by any congregant, and will seek to address them promptly and thoroughly. Similarly, the committee assists and supports the minister in his role. The committee, in addition, informs itself on matters of compensation and makes a recommendation to the board as appropriate.

A lesser-known function of the COM is to serve in an ombuds capacity when conflicts arise between members of the congregation, and the presence of a neutral third party may be of assistance. The congregation may expect both confidentiality and sensitivity in these matters.

Please feel free to contact any member of the COM at any time. We welcome criticism, compliments, and suggestions. The members of the committee, selected jointly by the board, min-

ister and congregation, include Caroline Nixon (Chair), Reed Bilz, Jane Palmer, Mark McMurry, and Maria Schmidt.

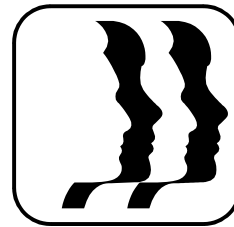
Bring a Friend to Church Sunday (9/2)
